The current edition, the eleventh, includes basic statements on academic freedom, tenure, and due process; academic governance; professional ethics; research and teaching; online and distance education; intellectual property; discrimination; collective bargaining; accreditation; and students' rights and freedoms.

Journal of Academic Freedom. Publishes scholarship on academic freedom and on its relation to shared governance, tenure, and collective bargaining.
